All Chester Country RC Members Must Agree to the Following Terms & Conditions:

- 1) Desiring to be legally bound, all members of Chester County R/C operate under FAA, AMA, and CCRC rules. By signing this application, you agree to learn and adhere to those rules, including but not limited to:
 - A. Successful passage of *The Recreational UAS Safety Test* (TRUST) found at https://www.faa.gov/uas/recreational_flyers/knowledge_test_updates and registration of your aircraft on the *FAADroneZone* at <https://faadronezone-access.faa.gov/#/>. The FAA registration number must be visible on all aircraft, and the member's TRUST certificate and proof of aircraft registration must be in the member's position when flying at CCRC fields. Members must comply with all *Rules for Recreational Flyers* found at https://www.faa.gov/uas/recreational_flyers.
 - B. Current membership in Academy of Model Aeronautics (AMA), visible placement of the member's AMA # on all aircraft, and compliance with all AMA rules and safety guidelines. Everyone crashes, it's just a matter of "when." While serious damage and injuries are rare when flying in a safe manner, they are ONLY covered by AMA insurance IF you are operating in compliance with all AMA, FAA, State and local rules and laws.  - C. Current membership in the CCRC and compliance with *The Bylaws & Standing Rules of the Chester County Radio Control Club* available at <https://chestercountyrcc.com/CCRC-Bylaws-Standing-Rules>. The member's CCRC Membership Card must be with you whenever flying at a CCRC field, and we suggest you keep it in your flight box. Members must also abide by rules established with our neighbors and partners at club flying fields. This includes appropriate flying times at each location, property speed limits when entering or leaving the property, local flight boundaries, etc. We share space at our flying fields with private individuals, businesses and gov'ts and maintain a commitment to be good neighbors.

- 2) These conditions are essential for your own protection as well as that of other club members, the club's AMA charter, and the use of the club's properties and privileges. The penalty for violation may be the termination of membership without recourse. If you are in doubt, ASK! Your fellow club members will be more than happy to offer helpful guidance. Ultimately, it is your responsibility to be aware of the rules and follow them for everyone's benefit, including your own.
- 3) All of the above will be covered with you personally throughout your new member orientation period. Club members will help you to learn and know the details and how best to enjoy the hobby while keeping in compliance with the rules. There is no "test" per se, though all new members must demonstrate safe piloting ability in a check-out flight before they can fly solo at CCRC fields. If you need flight instruction it is available at no charge from a certified AMA instructional pilot. A new member coordinator will be assigned to help you through the process as quickly and painlessly as possible so we can get to the fun stuff!
- 4) I understand that I am solely responsible for any and all consequences associated with my own actions and agree to hold harmless the club, its officials and the flying site property owners against any liability, claim, or damages to any person or property because of my actions.
